

The case of Adrian Glijin has been brought to attention of actors of the 5+2 negotiation format and international partners

attention the case of the citizen of the Republic of Moldova, Adrian Glijin, who is being held in an illegal detention on the left bank of the river Nistru for over 15 months.

Thus, additionally to the previously undertaken measures, a new complaint has been sent through the communication channel established by the office of the political representative of Tiraspol and the participants in the 5+2 negotiation format, reminding that despite multiple requests from Chisinau, meaningful evolutions concerning offering of detailed information on this case and unconditional freeing of the citizen of the Republic of Moldova are lacking, the access of human rights defenders and those contacted by the relatives is not ensured, and although in December 2021 a short assisted meeting between Glijin A. and his mother has been organized at the place of detention, his health condition and the motives of his arbitrary detention have not been clarified, and further contact has been restricted again, including with close relatives.

It has been observed that the citizen Glijin A. is facing health issues, which aggravate in inhuman detention conditions and the necessity to ensure the possibility of his examination by independent doctors who would provide qualified assistance was reiterated.

It has been asserted that as consequence of the abusive violation of rights and inalienable liberties of Glijin A., his individual case is being examined at the European Court of Human Rights, and urgent measures are required in order to restore his

violated rights and attain positive results in light of compliance with the provisions of the European Convention for human rights and fundamental liberties protection from November 4, 1950, and with universal standards in the human rights sphere.

On a different note, it has been emphasized that Mr. Glijin A. is a citizen of the Republic of Moldova and in this regard a request has been filed for him to be taken into custody by the representatives of the constitutional justice institutions from the right bank of river Nistru in order to investigate and take required measures on the alleged criminal charge pressed in the region, according to the provisions of the working legislation.

The messages of Chisinau have brought forward the indispensability of protection and restoring of fundamental rights of Glijin A., ensuring all forms of needed assistance, including medical and legal, offering unrestrained access to relatives and legal representatives employed by them, and, of course, immediate freeing from detention with an end to the persecution measures.

An appeal has been repeatedly launched to the representatives of mediators and international observers within the "5+2" negotiation format to have an active contribution on this case, taking prompt measures and actively using the available potential to attain tangible progress and to guarantee fundamental rights and freedoms, according to the requirements of the international law.

Not least, an invitation from Chisinau to call a new reunion of experts in human rights from both banks of river Nistru in the near future has been renewed, in order to discuss potential actions to be taken for the insurance of respect for human rights in the region and solving individual cases, including the one of the citizen Glijin A.

Additionally, we specify that recently a separate request asked for the involvement and intervention of relevant foreign partners, in order to conjugate efforts with the national authorities and human rights-promoting non-governmental institutions for ensuring respect of fundamental rights according to the standards of the international law. Particularly, the request contained the message to ensure unrestricted access to A. Glijin of a qualified and independent physician in order to objectively assess his

health state and offer necessary assistance, and, of course, achieving his unconditional release from the illegal detention.
